

## ANNEX 70: REFERENCE GUIDE FOR TOURIST IMPORTS


**PLANTS, PLANT PRODUCTS, FRUITS AND VEGETABLES PERMITTED FOR TOURIST IMPORTATION**

The products listed in Article 4 of the AGREEMENT defining classification and merchandise coding are permitted in small amounts for personal use and consumption, after a visual inspection confirms they are pest free. Their importation is regulated by the Secretary of Agriculture, Livestock, Rural Development, Fish and Food.

Consumo humano	1	<b>Cheeses packaged and stamped by the corresponding sanitation authority.</b>	Fresh cheeses are prohibited. Aged cheeses are permitted and must be packaged and labeled in spanish or english and display a stamp from the sanitation authority. Their origin must be from countries in compliance with the zoosanitary requirements of the MCRZI. In the case of countries affected by Foot and Mouth Disease (FA), cheeses will only be accepted from plants listed in the SICPA. Homemade products are not accepted.
	2	<b>Canned or packaged butter stamped by the corresponding sanitation authority.</b>	Must come completely sealed and labeled in spanish or english and display a stamp from the sanitation authority and proceed from countries in compliance with the zoosanitary requirements of the MCRZI. If proceeding from countries affected by Foot and Mouth Disease (FA), the products will only be accepted if coming from plants authorized by Mexico. Homemade products are not accepted.
	3	<b>Canned cream stamped by the corresponding sanitation authority.</b>	Must come completely sealed and labeled in spanish or english and display a stamp from the sanitation authority and proceed from countries in compliance with the zoosanitary requirements of the MCRZI. If proceeding from countries affected by Foot and Mouth Disease (FA), the products will only be accepted if coming from plants authorized by Mexico. Homemade products are not accepted.
	4	<b>Packaged yogurt stamped by the corresponding sanitation authority.</b>	Must come completely sealed and labeled in spanish or english and display a stamp from the sanitation authority and proceed from countries in compliance with the zoosanitary requirements of the MCRZI. If proceeding from countries affected by Foot and Mouth Disease (FA), the products will only be accepted if coming from plants authorized by Mexico. Homemade products are not accepted.
	5	<b>Liquid pasteurized or ultrapasteurized bottled and labeled milk.</b>	Must come completely sealed and labeled in spanish or english and display a stamp from the sanitation authority and proceed from countries in compliance with the zoosanitary requirements of the MCRZI. If proceeding from countries affected by Foot and Mouth Disease (FA), the products will only be accepted if coming from plants authorized by Mexico.

	<b>7</b>	<b>Packaged and labeled dry milk.</b>	Must come completely sealed and labeled in spanish or english and display a stamp from the sanitation authority and proceed from countries in compliance with the zoosanitary requirements of the MCRZI. If proceeding from countries affected by Foot and Mouth Disease (FA), the products will only be accepted if coming from plants authorized by Mexico.
	<b>8</b>	<b>Packaged and labeled mother's milk.</b>	Product must come packaged and labeled. However, it may come in open or used bottles or in individual portions if the lactating infant is accompanying the product.
	<b>9</b>	<b>Dry cured Spanish ham coming from plants authorized by SAGARPA.</b>	Must come completely sealed and labeled in spanish or english and display a stamp from the sanitation authority. Must proceed from countries in compliance with the zoosanitary requirements of the MCRZI. Product is only accepted if proceeding from plants authorized by Mexico. Homemade products are not accepted.
	<b>10</b>	<b>Matured pork sausages from plants authorized by SAGARPA.</b>	Must come completely sealed and labeled in spanish or english and display a stamp from the sanitation authority. Must proceed from countries in compliance with the zoosanitary requirements of the MCRZI. Product is only accepted if proceeding from plants authorized by Mexico. Homemade products are not accepted.
	<b>11</b>	<b>Poultry or pork thermally processed sausages, packaged and labeled with a stamp from the corresponding sanitation authority.</b>	Must come completely sealed and labeled in spanish or english and display a stamp from the sanitation authority. Must proceed from countries in compliance with the zoosanitary requirements of the MCRZI. Product is only accepted if proceeding from plants authorized by Mexico. Homemade products are not accepted.
	<b>12</b>	<b>Fresh refrigerated or frozen pork meat. Packaged and stamped by the corresponding sanitation authority.</b>	The importation of these products is prohibited.

	14	<b>Packaged and labeled dried beef.</b>	Must come fully packaged, labeled in spanish or english with a stamp from the sanitation authority, and proceed from countries in compliance with the zoosanitary requirements in the MCRZI.
	15	<b>Packaged and labeled fully processed prepared foods with meat content of any species, egg product, honey and lactose (i.e. filled pastas, etc.)</b>	Must come fully packaged, labeled in spanish or english with a stamp from the sanitation authority, and proceed from countries in compliance with the zoosanitary requirements in the MCRZI. Products containing ground beef or similar, for example: meatballs, lasagna, ravioles, etc. are not permitted.
	16	<b>Paté of any species canned or bottled and labeled.</b>	Must come fully packaged, labeled in spanish or english with a stamp from the sanitation authority, and proceed from countries in compliance with the zoosanitary requirements in the MCRZI.
	17	<b>Natural bottled honey, labeled and sealed.</b>	Must come fully packaged with a stamp from the sanitation authority, and proceed from countries in compliance with the zoosanitary requirements in the MCRZI.
	18	<b>Campero chickens from Central America.</b>	This type of product is currently undergoing risk analysis.
	19	<b>Smoked poultry, such as turkey or chicken.</b>	Must come completely sealed and labeled in spanish or english and display a stamp from the sanitation authority. Must proceed from countries in compliance with the zoosanitary requirements of the MCRZI. Product is only accepted if proceeding from plants authorized by Mexico.
	20	<b>Balanced dry food, packaged and labeled, without ruminant content.</b>	A) A single day's ration of food, accompanied by the pet, or B) a complete package of pet food, labeled in spanish or english with a stamp from the sanitation authority; or proceed from countries in compliance with the zoosanitary requirements in the MCRZI.

	<b>22</b>	<b>Balanced canned pet food, packaged and labeled, without ruminant content.</b>	A) A single day's ration of food, accompanied by the pet, or B) a complete package of pet food, labeled in spanish or english with a stamp from the sanitation authority; or proceed from countries in compliance with the zoosanitary requirements in the MCRZI.
<b>Químicos farmacéuticos y biológicos</b>	<b>23</b>	<b>Medications or vaccines used for traveling pets.</b>	An application for the introduction of these products must be made to the Import and Export Division (DIE) directly to: MVS Montserrat Arroyo Kuribreña.
