#### A. DELIVERY OF APPLICATION.

Applicants living in Cyprus should deliver the application to the District Officer of the District in which they reside, or to the Assistant District Inspectors of their Area. Residents of the Nicosia Area are exempted from this arrangement and they may submit their application direct to the Migration Office in Nicosia. Applicants who live abroad must submit their application to a Cyprus Embassy or a British Consular Office.

#### B. DOCUMENTS THAT SHOULD ACCOMPANY THIS APPLICATION.

All applicants should produce their Identity Card when submitting this application together with the following documents/fees—

1. The required fees should be paid in cash against receipt. These are €42,72 for a Passport (€68,34 in cases of replacement of lost Passport) and €17,09 for a Travel Document.
2. Two recent photographs of size 4 X 5 cm, one of which should be certified from the person who countersigns **PART V** of this application.
3. The previous Passport or Travel Document.
4. Birth certificates of the children that will be included in the Passport. (PART III of Form should be completed and signed by both parents of the children).
5. Persons who submit applications for a Passport or Travel Document **for the first time** should submit in addition the following documents:
  - (a) Official birth certificate in original.
  - (b) Official marriage certificate (if applicant is a woman who is married or widowed).
  - (c) Certificate of Cyprus citizenship, in case where the applicant acquired the Cyprus citizenship by registration or naturalization.

All the above documents are returned together with the new Passport or Travel Document.
