IMPORTANT TRAVEL INFORMATION FOR TRAVELLING FROM GERMANY TO CYPRUS

According to the updated categorisation of Countries, based on their epidemiological situation, the Federal Republic of Germany is, as of 9 November 2020, considered a CATEGORY B country.

If you are travelling to the Republic of Cyprus from Germany (Origin Country of Departure) or if you have stayed/lived in Germany within the past 14 days before your travel to the Republic of Cyprus or you will be a passenger on an international journey to the Republic of Cyprus via Germany with an overnight stay, you are required to present a negative PCR test for Covid-19, carried out up to 72 hours prior to your departure for Cyprus.

If you belong to at least one the following passenger categories, you have the option to request the COVID-19 test to be carried out upon arrival to the Republic of Cyprus (Laboratory tests will be carried out on arrival, at the price of 60 euros). You will be required to self-isolate until you receive the results of your test. The categories are:

- 1. Cypriot citizens and their family members (foreign spouses, minor children and their parents).
- 2. Persons legally residing in the Republic of Cyprus.
- 3. Persons allowed to enter the Republic of Cyprus under the Vienna Convention.

For all other passengers, the results of a PCR test have to be carried out before departing to Cyprus (max. 72 hours).

All passengers traveling to Cyprus need to apply for the "Cyprus Flight Pass" up to 24 hour prior to their departure to Cyprus, through www.cyprusflightpass.gov.cy. The Cyprus Flight Pass needs to be presented before departure to Cyprus.
